**CONDITIONS GOVERNING THE ACCEPTANCE OF ITEMS FOR EXAMINATION  
BY THE EXPERT COMMITTEE**

1. The Philatelic Foundation seeks to render a public service in expressing the opinions of staff, knowledgeable collectors and professional consultants who serve as members of its Expert Committee. (The fees charged for the service contribute to the maintenance of the Foundation). However, The Philatelic Foundation does not guarantee the accuracy of any opinion expressed by its Expert Committee regarding any item submitted for authentication and disclaims any liability whatsoever for any loss, damage or injuries allegedly suffered as a result of any opinion issued by the Expert Committee.
2. The Foundation reserves the right at all times to decline to examine or give an opinion or analysis on any item.
3. The Philatelic Foundation reserves the right to use all information acquired on items submitted for certification for research or other purposes in the furtherance of philatelic knowledge, including the right to publication of same without disclosing the name of the applicant or submitter.
4. If an applicant seeks an opinion regarding an item the Foundation has previously declared genuine, the applicant must submit, along with the application, the original certificate of authenticity. In the event that any item, previously declared genuine by the Expert Committee is, upon re-submission, declared not genuine, then the applicant hereby grants to the Foundation the right to retain any such prior authentication and agrees to make no claim for the return thereof.
5. Submission of all stamps and other items to The Philatelic Foundation shall be entirely at the submitter's risk. All items submitted are accepted by The Philatelic Foundation with the express agreement of the applicant that The Philatelic Foundation, its officers, trustees, agents, committees, professional consultants and employees shall in no way be liable or responsible for any loss, damage or other physical injury to the stamps and other items submitted arising from any reason whatsoever, except for acts or conduct constituting gross negligence of The Philatelic Foundation or its officers, trustees, agents, committees, professional consultants and employees. All items are passed through the Expert Committee anonymously and the names of the submitters are not divulged.
6. Items submitted will be returned as soon after examination as possible. However; The Philatelic Foundation shall in no way be liable for any delay in returning items or for any delay or failure of the U.S. Postal Service, FedEx or other private carrier in making delivery of same.
7. The Philatelic Foundation and its Expert Committee reserve the right to make such changes in the fees, rules and conditions as they deem necessary without notice, but such changes will be promptly announced on its website and thereafter in the philatelic press.

**PLATING: Requests for plating of submissions will be honored, when possible, for an additional fee of \$25.00.**

**HI-VOLUME DISCOUNT PROGRAM: Discounts up to 20% are available. Contact office for details. A \$1,500.00 contribution is required.**

**ADDITIONAL FEE INFORMATION:**

The above fees are applicable notwithstanding an adverse opinion by the Expert Committee regarding the authenticity of any item. However, fees will be adjusted in the following cases:

For fees on foreign stamps, see our website.

For any item not valued in any standard catalogue, or the value of which is enhanced by condition, the fee will be based on an appraisal by professional consultants to the Expert Committee.

If a stamp is found to have been misidentified by the submitter, i.e. wrong catalog no., used rather than unused, etc., the fee will be based on the value of the correctly identified stamp.

The fee for counterfeits and forgeries will be the minimum, \$27.00.

If after deliberate consideration the Expert Committee is unable to issue an opinion regarding the authenticity of any submitted item, a fee of \$27.00 will be charged.

**ADDITIONAL SERVICES (Fees will be invoiced separately. Please contact our office for specific information).**

Duplicate Certificates: Duplicate certificates for certified multiples are available at \$6.00 each if a request is made at time of submission.

Separation of Multiple: Individual stamps from a previously certified multiple are eligible for separate certificates provided the multiple is broken in the presence of a member of the Expert Committee. The fee for each separate certificate is \$15.00 per stamp.
